### **Attaching Signs to Utility Poles Presents Safety** Hazards-And It's Illegal

During the summer months, it is common to see garage sale or yard sale signs attached to utility poles. Although seemingly innocent enough, putting signs or other items on utility poles creates serious safety hazards. Staples, nails, and tacks used to hang signs—as well as the signs themselves—pose dangers to Cookson Hills Electric Cooperative lineworkers who must climb poles when either restoring power following storms or while performing routine maintenance to ensure system reliability.

Posters or other objects (birdhouses, balloons, flags, and even basketball nets) can create dangerous obstacles. Also, the nails and tacks left behind from signs can snag utility workers' boots or puncture safety clothing, making lineworkers vulnerable to slipping or even electrocution.

In addition to being hazardous, tampering with utility poles can be costly. Posting signs or attaching other objects to utility poles without the electric utility's consent is against the law.

### **Electrical Safety Demonstration**

Cookson Hills employees, Marty Huff and Donna Rhodes gave an "electrical safety demonstration" at the boy's ranch north of Gore. The Circle of Care United Methodist Boy's Ranch provides care for young men - ages 13 through high school graduation – who are experiencing problems which prevent them from living at home or in foster care.

The presentation is an informative and entertaining demonstration. Participants learn how electricity works, where electricity is generated. the transmission of electricity, home safety, and how to prevent accidents involving power lines and home appliances.







### Let Your Fridge Just Cool It

If we had to choose one appliance we just couldn't live without, many of us would choose our refrigerator, the workhorse of the kitchen. Without a refrigerator, we couldn't keep fresh milk, cheeses, produce, and more. There would be no ice cream treats, ice cubes, or stocking up on meats and frozen pizzas.

On the downside, though, our BFF (best friend fridge) contributes to more than 11 percent of home-energy consumption. According to Energy Star, if you're still storing your food in a fridge that's 10 years or older, you could save hundreds of dollars on your energy bill by replacing it with an energy-efficient model.



For example, a new energy-efficient fridge uses 75 percent less energy than a late 1970s model consumes, and if you replaced a 1980s style fridge with a modern day fridge you could cut over \$100 yearly from your utility bill. While Energy Star products generally cost more up front, the Department of Energy estimates that the payback is 3–5 years because of the reduced energy consumption.

If a new fridge is in your near future, consider a few things before making your purchase:

- \* While convenient, a side-by-side fridge-freezer unit uses up to 20 percent more energy than a top/bottom unit.
- \* Expect a fridge with a water and ice dispenser to consume 15–20 percent more electricity than the exact same model without this feature.

### Four miles of new line near Old Panther

Cookson Hills Electric Cooperative is in the process of upgrading their facilities in the Old Panther area southwest of McCurtain. Four miles of single phase overhead line is being converted to three phase line.

This upgrade will add additional capacity in this area as well as improve voltage and reliability. Cookson Hills Electric Cooperative has contracted with Winsett Electrical Contractors to perform this system upgrade. This project will be finished by early September, weather permitting.
