Members Who Bought Electricity During 1993 Will Receive a Capital Credit Check



When you signed up to receive electric service from Cookson Hills Electric Cooperative (CHEC) you became a member. This month, people who were members of CHEC in 1993 are receiving a capital credit check. These funds helped us keep the lid on rates, reduced the amount of money we needed to borrow from outside lenders to build, maintain, and expand a reliable electric distribution system, and covered emergency expenses.

Investor-owned utilities return profits back to their stockholders who may not live in the same region or even the same state. Electric cooperatives operate locally and are non-profit organizations. As a member, you share in the profits in the form of capital credits. CHEC allocates and periodically retires capital credits based on how much electricity you purchased during a year.

The CHEC Board of Trustees has authorized the distribution of \$676,315.13 in capital credits. Checks will be mailed by the second week of December to active and past members who received electric service from CHEC in 1993.

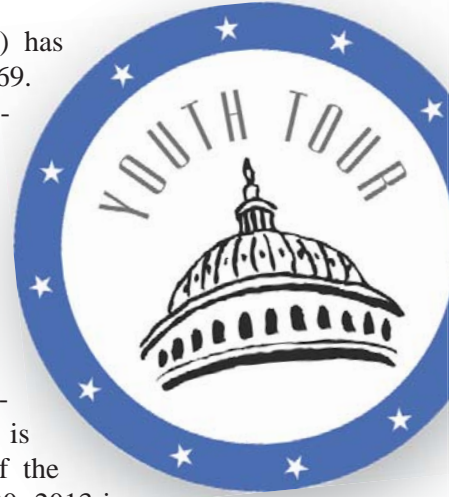

Sealing your Ducts makes a **Difference**

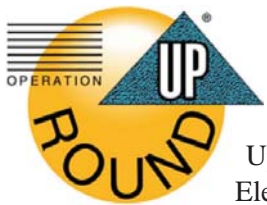
Leaky ductwork can reduce the overall efficiency of your heating or cooling system by as much as 20 percent. In other words, you could install an energy efficient furnace or heat pump, but leaky ductwork could reduce the efficiency by 20 percent.

The solution can be simple, use metal-backed tape or duct mastic (a paint on sealer) to seal all the seams in metal ductwork that runs through unheated spaces (attics, crawl spaces, and garages).

If your ducts are easily accessible, you may be able to seal some leaks on your own. An easy first step is to check if ducts have become disconnected and reconnect them. Next, check the duct connections for leaks by turning on your heating and cooling system fan. If you 1556502 feel air leaking around the duct joints, apply a proper sealing material.



Operation Round-Up Helps Support Angel Tree



Through a giving program known as Operation Round-Up, Cookson Hills Electric Cooperative (CHEC) members

will help to make the holidays brighter for underprivileged children with a grant to the Haskell County Angel Tree Program.

Operation Round-Up is a community outreach program that is funded by CHEC members who round-up their electric bills each month. The small change that results from "rounding-up" monthly electric bills, 50 cents on average, has made a big impact in the cooperative's seven county service area.

The Cookson Hills Electric Foundation, which meets every quarter to review applications, has approved a \$5,000 grant to help assist with the Haskell County Angel Tree Program. This grant will help with purchasing wishes for any

remaining Angels.

The last three years, Stigler Health and Wellness Center has coordinated the Haskell County Angel Tree program. This year they are partnering with Haskell County DHS and Wal-Mart. The Angel Tree will be set up in the front entrance of the Stigler Wal-Mart.

"Families interested in registering a child for the Angel Tree may go to the Haskell county DHS office and fill out an application for the program. DHS will review the application and present the family with an Angel Coupon, which will be placed on the Angel Tree, if they meet the requirements," said Lindsey Apple, Angel Tree Coordinator.

The Haskell County Angel Tree program provided nearly 800 children with gifts last year.

The Stigler Wal-Mart will have the Angel Tree decorated with paper angel tags listing a child's age, gender and toy suggestion as

well as the child's clothing sizes. Anyone wanting to participate can select an angel tag from the tree and purchase a gift for a child. The purchased items for the angel can be dropped off at the Stigler Health and Wellness Center.
